# A BILL

To promote the adoption of a binding Global Migration  
Agreement, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Global Migration  
5 Agreement Act”.

6 **SEC. 2. GLOBAL MIGRATION AGREEMENT.**

7 (a) IN GENERAL.—The Secretary of State, the  
8 United States Permanent Representative to the United  
9 Nations, and other officials of the Department of State

1 shall use the voice, vote, and influence of United States  
2 in bilateral relationships and multilateral organizations to  
3 promote the adoption of a binding Global Migration  
4 Agreement that should—

5 (1) address the root causes of migration, the  
6 vulnerabilities faced by migrants, and integration of  
7 migrants into their new countries;

8 (2) centralize the human rights of migrants, in-  
9 cluding their rights to health;

10 (3) recognize the particular vulnerabilities of  
11 marginalized groups, including—

12 (A) women;

13 (B) members of the LGBTQIA+ commu-  
14 nity;

15 (C) racial, ethnic, and religious minorities;

16 and

17 (D) indigenous people;

18 (4) establish clear, ambitious quantitative and  
19 qualitative benchmarks according to each country's  
20 capacity and need;

21 (5) provide global funding for crisis response in-  
22 volving migrants at risk, whether their migration is  
23 internal or cross-border;

1           (6) establish clear reporting requirements for  
2 countries on their progress in achieving the bench-  
3 marks specified in this subsection;

4           (7) establish mechanisms for support, including  
5 funding, for countries and localities taking on a dis-  
6 proportionate burden of forced migration;

7           (8) expand and revise existing categorizations  
8 and definitions of migrants to incorporate classes of  
9 vulnerable migrants who are currently unprotected  
10 by international norms and laws; and

11           (9) establish clear consensus on the due process  
12 rights of migrants, regardless of their motivations  
13 for migrating.

14       (b) REPORTS.—Not later than 180 days after the  
15 date of the enactment of this Act and every 180 days  
16 thereafter, the Secretary of State shall submit to the Com-  
17 mittee on Foreign Affairs of the House of Representatives  
18 and the Committee on Foreign Relations of the Senate  
19 a report on progress made toward adopting the Global Mi-  
20 gration Agreement described in subsection (a).
